#### Sunrise Garden

PPJPC in partnership with the City of Colorado Springs began gardening at the Hillside Community Center vegetable garden. Organic Food was grown for the local community and Seeds Community CafØ. PPJPC was offered to take over the management of Dorchester Park Garden by Pike Peak Urban Gardens and declined because we do not have the financial resources to pay someone to manage this garden and because the homeless do not have access to the city bathroom facilities located at Dorchester Park. The homeless broke through the fence surrounding the garden to drink and shower using the garden water. PPJPC would reconsider management of the Dorchester Park garden if the city of Colorado Springs reopened the public bathrooms

#### Homeless Advocacy

PPJPC regularly attends the CHAP and PATH meetings. We spoke up in opposition to the city's proposed sit/lie ordinance.

#### Immigrant Network

The PPJPC board of directors determined that having Casa De Paz (they house immigrant families in Denver) as an umbrella organization under PPJPC was making it difficult to do realistic financial accounting. At the end of 2015 Casa De Paz is no longer an umbrella organization under PPJPC.

#### Urban Experience

PPJPC conducted eight Urban Experiences for the following groups: First Congregation Church members, Broadmoor Community Church members, Unity Church members, St Patrick's Church members, D-11 teachers, UCCS students, and two for Colorado Springs School students. A total of 92 people participated.
